

WW x Amazon Halo Sweepstakes

- 1. SWEEPSTAKES PERIOD:** The WW x Amazon Halo Sweepstakes (the “Sweepstakes”) begins 12:00 a.m. Eastern Time (“ET”) on September 8, 2020 and ends 11:59 p.m. ET on November 9, 2020 (the “Sweepstakes Period”). The Sweepstakes Period will consist of nine (9) weekly entry periods (each an “Entry Period”), as listed in the chart below. Each Entry Period will begin at 12:00 a.m. ET and end at 11:59 p.m. ET on the dates listed.

- 2. ELIGIBILITY:** The Sweepstakes is open only to legal residents of 50 United States and District of Columbia, who are 18 years of age or older as of date of entry. Employees of WW North America Holdings, LLC. (“Sponsor”), Don Jagoda Associates, Inc. (“Administrator”), Amazon.com, Inc., and each of their respective parents, affiliates, subsidiaries, advertising, promotion and internet agencies and their immediate family members and/or those living in the same household of each are not eligible to participate or win a prize. - **CURRENT WW MEMBERS:** Current WW members will receive one (1) automatic entry into the Sweepstakes each time they earn fifty (50) Wellness Wins during the Sweepstakes Period.
- **WWShop:** For every order placed from the WWShop during the Sweepstakes Period you will receive one (1) automatic entry into the Sweepstakes.
- **ALTERNATE METHOD OF ENTRY:** You may earn an entry by hand printing your first and last name, street address (no P.O. Boxes), city, state, zip code, date of birth and e-mail address on a plain piece of 3”x 5” paper. The ARV of each prize is \$99.99. An Amazon account is required to use the Amazon Halo Band and membership. After the six (6) months, your Amazon Halo membership will auto renew at the applicable rate if you have a credit card on file with Amazon, until you cancel. A credit card is not required to activate the prize. If you do not already have an Amazon account, you may set one up for free at www.Amazon.com. The drawings will be conducted by Administrator, an independent judging organization whose decisions are final on all matters relating to the drawings.
- 6. WINNER NOTIFICATION:** The winners will be notified via email by Sponsor and will need to follow the instructions in the email to redeem and claim their prize. If email notification is returned as undeliverable, prize will be forfeited and an alternate winner will be selected from among all Entries received by the end date of the applicable Entry Period.
